What is the Federal Surplus Personal Property Program?

Personal property no longer needed by the Federal government is available for donation to eligible organizations through the Federal Surplus Property Program.

All items are made available to your organization through the State Agency for Surplus Property (SASP) in your home state. Participants are assessed a service charge that covers the SASP's administrative costs.

The SASP is responsible for the fair and equitable distribution of all surplus property allocated to the state and to ensure compliance of all conditions and restrictions surrounding the property.

Federal law limits eligible participants to:

Property Restrictions:

- ◆ All property must be placed into use within one year, and must be used for a minimum 12-month period.
- ♦ Higher value items will have an extended utilization period.
- Property is restricted to organizational use only; no personal use of property is permitted.
- Property cannot be sold, loaned, leased or traded during its compliance period.
- Property must be used by the receiving organization only and cannot be transferred.
- Failure to comply with these terms and conditions may require payment to the US Government for the value of the property.
