## **NASASP** Overseas Facilitator Report

Dear Members,

After almost 29 years, it is time to say good-bye. It has been a good run. I hope the program survives and is restarted in the future.

In 1994, I was a buyer at DRMO Okinawa, Japan. I was out screening some pickup trucks when I noticed an old American man screening also (mind you I was 35 at the time). Out of curiosity, I decided to speak with him. Soon after Woody Carpenter hired me, and I was working for NASASP.

I handled all of Asia in the early days. We shipped 25 container loads of ration supplements out of Sagami, Japan; 24 container loads of sandbags out of Sagami for the Midwest floods of 1996; and many loads of vehicles and equipment out of Korea. We shipped from Hawaii, Guam, the Mariana Islands, and many remote locations. I was not home much in those days.

After moving back to Maine in 1998, I took on Germany and in 2000 I took over management of the NASASP Overseas Program. Over the last 20 years or so, we have shipped property from many locations, Afghanistan, Iraq, Bosnia, Bahamas, Antigua, Norway, Crete, La Maddalena, Azores, Iceland, Kuwait, Bahrain, Qatar Djibouti, and so on. We shipped thousands of pieces out of Sierra Army Depot, California.

I was fortunate to travel with several of the NASASP officers over the years, Shane Bailey, Steve Ekin, Bill Wilson, Arthur Woods, Curt Howard, Bill Beard, Scott Pepperman, and others. Shane and I went to a lot of places. So many stories. I always said I could write a book on travels with Shane, but it's probably better left unsaid. I was there for the decommissioning of the U.S. base in Iceland and La Maddalena. Many bases around the world have closed during my time working overseas. (continued on next page)

One day I was screening a Humvee Fire Truck at the crack of dawn. I needed a flashlight to read the odometer. Out of nowhere a black cat jumped in my lap, looked me in the eye, let out a loud howl, and jumped out of the door. I think I lost a couple years of my life at that moment.

If you haven't noticed, this job was a great part of my life. My interests, and abilities were a match for this work. I never intended to work for NASASP this long, but I liked the work and kept on doing it.

I would like to thank everyone with NASASP (past and present) for the years and experiences. I would also like to thank every town, county and customer that has worked with me over the years. Thank you to all the

federal agencies that have worked with me to make this job possible.

I will miss all of you, the travel, and yes, the equipment!

#### JJH Earthworks (Washington)

In need of a generator to power large-scale water filtration projects, JJH Earthworks turned to DES and the federal surplus program available to veterans who own small businesses.

JJH Earthworks is a veteran-owned company providing environmental and construction services within the Pacific Northwest and west coast, including green energy projects and fish rehab projects. Among its environmental services, the company conducts on-site water filtration and treatment in areas that have no electricity so generators are required to power all tools and equipment. Owner Jeff Huber found his company's generators weren't large enough for large water treatment jobs and wanted to purchase a large generator to take on this large scale project. Being a start up though, they could never afford a large generator like that. But

after doing research, he learned about the Veteran Small Business Enhancement Act, which makes federal surplus items available to veterans who own small businesses. Through the act, Washington's DES Surplus Operations is able to manage the distribution of federal surplus property to veteran-owned small businesses. After his company certified as a Service Disabled Veteran-Owned Small Business, Jeff contacted Dale Richardson with the DES Surplus Operations federal team, who promptly found and transferred a 10kw generator to JJH Earthworks. "JJH Earthworks acquired this generator to power a water treatment station in Duvall," said Dale. "In one weekend alone, the generator was able to process over 150,000 gallons of turbid water and discharge it back into the Snoqualmie River wetlands."



Jeff's company can now do larger jobs to restore and protect fish habitat. They are currently restoring a creek that was taken out in the 1960s. They will be reconnecting the creek to its historial habitat. He says the generator is quiet, which is important because they want their presence to the least intrusive as possible. And it runs on diesel fuel, a cleaner alternative to gasoline. "Having a couple of generators, conex, and welder totally upped our game. From fixing equipment to powering pumps for water treatments. It's impossible to get a conex right now but DES got us one. It's now on the stream rehab in Packswood. We are a veteranowned company and have some benefits accordingly, but we still have to get out and hustle and work," said



Jeff. "Showing up to a job with good gear establishes value, especially in the critical area where that generator is at now."

#### **Anderson Wood Products (Missouri)**

Veteran-Owned Small Businesses (VOSBs) are the newest eligible organizations in the Federal Donation Program, which is operated by the Missouri State Agency for Surplus Property (MOSASP). In 2019, legislation was passed enabling VOSBs to access the program, and in 2021, many began obtaining property from state SASPs.

MOSASP has witnessed a steady increase in the number of VOSBs that want to join the program. Anderson Wood Products is one of several VOSBs who have been utilizing services of MOSASP, which allows them to pay a small service charge for items.

Anderson Wood Products, founded in 2011, first produced dimensional lumber that was sold to hickory handle manufacturers to produce tool handles.

"In 2013, I had the opportunity to purchase a hickory tool handle manufacturing company in Van Buren. Our business grew fairly quickly. After a devastating loss due to fire in 2015, and the inability to replace the machines that we produced handles on, I decided to open a grade lumber and railroad tie facility in Ellington," owner Ron Anderson stated.

In 2021, after becoming qualified as a VOSB, Anderson began to acquire equipment from MOSASP and makes frequent visits to the Jefferson City warehouse.



"It has been a great resource for my business. I have acquired everything from hand-tools, and banding carts, all the way up to a Cessna 182 airplane. Each item is as important as the other to the success of my business," Anderson stated. "I have worked with several people at MOSASP. Everyone has a passion for what they do and go OVER THE TOP in addition to being helpful and knowledgeable. I am very thankful and grateful for what they do and for the program."

Anderson's company has been able to save thousands of dollars by utilizing MOSASP. He was able to acquire a Cessna airplane. Anderson's company paid a service charge of \$1,000 to MOSASP. MOSASP is thrilled to be able to offer this program to VOSBs to enable them to stretch their budget dollars ever further during tough economic times.

#### **Yoshida Solutions (Texas)**

Yoshida Solutions, a Veteran Owned Small Business received a 1978 Ford 455C Backhoe (*pictured below*) from TX SASP's Federal Surplus Property Program in May 2022. The VOSB was able to get the backhoe fully operational after getting the bucket, cylinder seal, and hydraulic hose set repaired. They have been able to move dirt, install irrigation, clear brush, plant trees, and place heavy materials that were costing the business over \$400 per day to complete prior to the acquisition.

"As we get our operation up and running, this equipment quickly turned from a cost offset to a revenue generator as we use the equipment to support new customers. The cost of new equipment at this early stage was cost prohibitive, making the progress very slow. The surplus program was a godsend allowing the business to get up and running faster. I am experiencing up to 70% cost savings compared to leasing or buying brand new by being involved in the veteran surplus program." – Alan Yoshida, CEO

The service charge paid for the backhoe was \$7,500 with an original acquisition cost of \$25,652, saving the VOSB \$18,152.

#### **Veteran Events (Illinois)**

The Illinois State Agency for Surplus Property is working hard on getting out there and attending conferences and meetings with all types of donees, and is working on hosting live and virtual informational events for the program.

One of the donee types that has seen the largest growth from our efforts are the Veteran-Owned Small Businesses. We currently have 42 VOSB's and our Veteran-Owned Small Businesses have acquired 2,790 pieces of property, totaling \$14,637,482.93 in Original Acquisition Value.

In September, ILSASP attended and presented at the AMVETS conference to reach out to VSO's and VOSB's. In October, ILSASP, along with CMS Personnel, participated in the Veterans Resource Fair hosted by the Illinois Speaker of the House, Chris Welch.




#### **Donee Appreciation Day (Arkansas)**

# **NASASP Government Relations Report**

#### 2023 to be a Complex and Busy Year in Congress

The last time a Republican U.S. House contended with a Democratic controlled Senate and President was twelve years ago in four years of the Obama term (112<sup>th</sup>-113<sup>th</sup> Congress, 2011-2015) and before that, in the 36th Congress, 1859-1861, prior to the Civil War! Therefore, we can expect new and varied tactics to be considered in moving or opposing legislation, regulations, and policies in a very complex environment on Capitol Hill for the next 24 months until the 2024 national elections.

The NASASP and SASPs should expect an interesting year for federal government initiatives and Congressional impacts on GSA, SBA, DoD and the Federal Surplus Property Program. Key among these is the revisions to Title 40 that have been pursued by NASASP in the last Congressional process. Revision to the priority for SASP access to GSAXess ahead of exchange/sale selections and review of the exchange/sale criteria for vehicles, equipment and other federal surplus property that can be re-utilized by nonprofits and donees around the country. There has been great interest in NASASP's outreach to the U.S. Senate and U.S. House on the educational aspects of Federal Surplus Property especially targeting the recent 75th Anniversary of the program and pointing out that the real start of a Surplus Property Act was in 1944, at the end of World War II in which Congress declared that State donation has priority next to federal agency reuse.

Other major possible 2023 activities in Congress are the programs of the new U.S. House Republican leadership with jurisdiction over NASASP issues. Top of this agenda is the House Oversight and Reform Committee, now to be headed by Rep. Comer (R-KY) and the House Small Business Committee to be headed by Rep. Leutkemeyer (R-MO), as well as the House Armed Services Committee, to be headed by Rep. Rogers (R-AL). The U.S. Senate leadership in areas of jurisdiction will not change.

2023 will also see thousands of bills and thousands of regulations introduced and considered during the year. Over 75 new members of Congress with hundreds of changes in staff and turnover in the agencies as well. NASASP keeps up-to-date tracking, monitoring and reporting to the NASASP leadership of any impact by these proposed rules or legislation for review.

The following are selected considerations for NASASP and our efforts in the 118<sup>th</sup> Congress, which will be sworn in January 3, 2023:

- The marginal issue of Control: In the few divided government scenarios we know of, a very close majority vote (222 in the House out of 435, majority is 218 so the GOP have a very small margin of 4-5 votes in passing anything... and 51 in the Senate) signal major issues on any divergent group of House or Senate members can defeat legislation or amendments. 2023 is a very political year with eyes focused on 2024, when 21 Democrat Senators will be up for election, including 2 "independents," Senators King (I-ME) and Sanders (I-VT), against 10 GOP members. Every election cycle now is a battle for majority control...
- Use of the Veto by the White House: Many bills will be influenced in 2023 by GOP House procedures and sent to the President for signature. These might include many funding provisions and stand-alone bills that are amended in the House once sent over by the Senate. A Presidential veto requires a two-thirds vote in the House (290+votes out of 435, which will require Democrat votes beyond the 219-220 of the GOP, an issue itself...) The Senate also requires a veto override vote of two thirds (67 votes out of 100) way above the 51 Democrat vote total). Commensurate with an inability to veto override is the issue of a government "shutdown" in the Fiscal Year 2024 cycle.

NASASP is maintaining its vigilance. We are also maintaining access and positions on all aspects of the Federal Surplus Property Program and cooperating with Congressional leadership, professional staff and agencies that have jurisdiction over our issues in GSA, DoD/DLA, SBA, VA and many others.
